## Symphony No. 5 & Symphony No. 4 (Biodiversity) Recording Project

Internationally recognized composer Carson Kievman's *Symphony No. 4* (*Biodiversity*) was motivated by the suggestion that a musical piece could help to draw global awareness of coral reef ecosystems and perhaps persuade people to take simple actions that benefit the reefs. This orchestral work is an enthralling four-movement reflection on the fragility of our natural world - *Glaciers* (*Rivers of Ice*), *The Great Swamp*, *Starving Angels*, and *The Year of the Reef*. Its symbiotic pairing, *Symphony No.5*, was inspired by the natural environs of the Everglades and the Florida Keys.

Even in his formative years growing up in California, Dr. Kievman's work has resonated with intrinsic passion for nature and its interdependent ecosystems. His personal connection to nature has only deepened over the years.

The challenges of connecting otherworldly music with environmental fragility are steep and the causal linkages are often complex. Sustainability, degradation, illicit extraction of resources, and the consequences of conflict over revenue from high-value resources are all themes that he has explored in depth in earlier music and multimedia works, including *California Mystery Park*, *Multinationals & the Heavens, Intelligent Systems*, Symphonies Nos. 3, 4 and 6 (*Hurricane* and *Biodiversity* and *No Man's Land*) and the upcoming opera *Tesla*.

We currently have raised \$28,000 in governmental, individual and foundation donations and pledges. Once the complete \$38,000 recording budget is in place, we will move forward with conductor, Delta David Gier, hire a world-class recording ensemble, book the recording hall and pay for associated travel costs. We plan to make the recording in 2017/18
